ORDER OF AMENDMENT

(By: Burns, C.J., Watanabe and Nakamura, JJ.)

1. Due to a printing error, the printed version of the opinion of the court, which was filed on March 24, 2005, skips from footnote 2 to footnote 4. The printed version of the opinion is hereby amended by renumbering footnotes 4 through 14 as footnotes 3 through 13 in both the text and the footnote. Thus, footnote 4 should be renumbered as footnote 3, footnote 5 should be renumbered as footnote 4, and so forth in the printed version. This footnote-numbering amendment only applies to the printed version of the opinion that was filed. The footnotes in the electronic version of the published opinion that was submitted are correctly numbered and therefore no changes in footnote numbering should be made to the electronic version.
