To meet Hawaii's requirements, a Certificate of Good Standing must be issued by a jurisdiction's highest court and licensing authority and must verify the following:

- Your full name as listed on your license
- Current name with proof of name change, if applicable
- Current status (active, inactive, suspended, etc.)
- Are you in good standing? Able to practice law in the jurisdiction you are licensed?
- Bar number
- Date and place of admission
